7. INSPECTION AND EQUIPMENT FAILURE

The voyage may be terminated by PACIFIC DELIVERY LTD if, in the Skipper's judgment, the vessel is considered unsafe, then PACIFIC DELIVERY LTD will be paid the daily fee plus all expenses incurred including the cost of return airfares for Skipper and crew (if any). All remaining monies advanced in excess of what

is due to PACIFIC DELIVERY LTD will be returned to the Owner or his agent by PACIFIC DELIVERY LTD.
